Simultaneously, we're addressing critical challenges in healthcare pricing:

# The National Health Insurance (NHI) Act: What Does It Mean for Audiologists & Speech Therapists in private and public sectors?

The NHI aims to create a single, state-funded health system, where healthcare services are centrally purchased and provided to all South Africans, regardless of income.

#### However, this has key implications for our professions:

- Uncertainty Around Private Practice Under the current NHI framework, medical schemes may be restricted in funding services covered by NHI. This could limit opportunities for audiologists and speech therapists working in
- **Reimbursement & Service Pricing** The government will set standard tariffs for services, which may impact the financial viability of
- private practices if reimbursement rates are not sustainable.
- Employment & Workforce Challenges With centralisation, public sector workloads may increase, but there's little clarity on how many audiologists and speech therapists will be employed by the state. This could affect job
  - security and working conditions. **Limited Patient Choice** Patients may have fewer options in choosing specialists, impacting continuity of care and multidisciplinary team collaboration.



### Draft Interim Block Exemption for Tariff Determination: What It Means for You

The Block Exemption Regulations represent a significant shift in private healthcare pricing, with critical implications for our professions:

#### **Key Concerns for Private Practitioners:**

- Government-Controlled Pricing: The
  Department of Health is leading the pricing
  process, potentially limiting practitioners' ability
  to set fair service rates.
- Hospital Tariffs Dilemma: Consultation fees may be regulated, but high-cost hospital procedures and equipment remain unchecked, exacerbating affordability issues for specialised services.
- Legal Uncertainty: The use of the Competition Act for healthcare price control is being challenged, creating potential instability for private practitioners.
- Service Quality at Risk: Restrictive tariffs could compromise the sustainability of private practices, ultimately reducing access to quality care.
